- I will exercise "reasonable care" and "due diligence" in conducting a "visual" and "hands-on" marine survey/appraisal of the accessible areas of the subject vessel.
- Unless specifically stated otherwise, in my survey report/appraisal, this surveyor will not operate the engines, machinery, equipment, or appurtenances.
- I will report all "details", "particulars", and "findings" discovered during subject survey/inspections including "Safety Deficiencies", "Other Deficiencies Needing Attention", and "Surveyor's Observations".
- All "judgements", "conclusions", and "recommendations" will be expressions of my opinion based upon my skill, my training, and my experience after a careful examination of the vessel and its systems and after discussions with the owners or others familiar with the subject vessel.

- No part of my survey report will be issued as an expressed or implied "warranty" or "guarantee" of the "vessel's condition" the "vessel's value" the "vessel's replacement value", or the "cost of any repairs".
- The survey report will be issued for the sole use of the requesting party (work order signatory) and for an agreed fee based upon express use of the report and the legal liability of this surveyor.
